Overview

Below is a description of five new reports that have been created in Team Ohio and are available to users who have access to Team Ohio.

This article describes how to generate Team Ohio Reports Report and what Ohio SACWIS are impacted by Team Ohio.

Report Name	Description
Child Abuse/Neglect Reported Concerns	Captures the number and percentage for each type, and percentages for all the checkbox items of concerns
Concerns Not Included in Allegations	This report will allow users to track various kinds of abuse/neglect concerns reported that did not meet the criteria for screening in and were not included in the allegations screened in.
Screening Decision Timeliness	Percent/count of accepted reports for investigation or assessment initiated within the required time.
Total Report on all Allegations	captures the percentage of screen in/screened out intakes of Mandated or Non-Mandated reporter type
Disproportionality report	This report will show the race and ethnicity of child subjects compared to population and the demographics of reporters (census data) State Admin provision is needed to access this specific report



Navigating to Reports

Reports are located in the following area in **Team Ohio**:

1. Users will need to navigate to the Report area by selecting the drop down menu and selecting **Reports**.

Team Ohio impact on Ohio SACWIS Reports

- Safety Hazard Administration Report
- Human Trafficking Administration Report
- Intake Report Worksheet
- Family Risk Assessment
- Ongoing Case Assessment

Safety Hazards - will display the actual Safety Hazard if enter in Team Ohio

Human Trafficking Administrative Report - will display the Sex Trafficking or Labor trafficking type if entered in Team Ohio

Intake Report Worksheet: All areas of the worksheet has been updated to reflect changes for Team Ohio.

Three new questions have been added to the Intake workspace on the "**Basic Tab**", for Substance use and Concerns.

- Infants test positive birth for a legal or illegal substance
- Infant was exposed or affected by a legal or illegal substance with was misused by the parent during pregnancy
- Mother has participated in Medication Assisted Treatment or Medication or Opioid Use Disorder (MOUD)

As for the **Family Risk Assessment** and **Ongoing Case Assessment** report, if any checkboxes are marked for Substance use and Concern they will be on the report.
